The notes are ready to post and she will send them to Bob Kuntz shortly **Treasurer's Report** Cheryl Nardiello □ Balance Sheet Compared to last year this time, our operating account was about 22.2% We had about \$3,300 more in long term reserves this year compared to last year Budget vs. Actuals o The format of budgets vs actuals is different from the last few years to make it easier to read and understand

\$36,200 has come in for memberships, due to a good number of Affiliate memberships

Income or August was \$3,000, or 1.25% of the budget
 Fundraising income is already at 19.78% of the budget

- o Gross profit came in at \$45,267.50, or 12.61% of the budget so far
- Credit card fees came in at \$450.86
- Scholarship expenses were at \$500
- We have spent \$400 on the Centennial Carnival, 6.28% of our fundraising budget for the year
- Personnel expenses include what looks like a bill from last FY that was put into this current year for employee insurance
- Total expenses come in at \$16,349.30
- Net income is at \$28,918.20

- Tif would like to get the vote settled today if possible
- o Joe Thompson, also in Carroll County, has two thoughts to share:
  - The Southern Poverty Law Center has called this group "extremist," but it may not be helpful to call them out this way in our letter because it could lose some of our audience
    - ☐ Tracy Miller suggests we just name the group (Moms for Liberty) instead of naming them just an extremist group.
    - ☐ Tamar suggests we name the group as having extremist views rather than calling the group extremist
  - Does it matter what the polling says about how parents feel about book banning? Joe suggests that we are standing behind what we know is right (intellectual freedom) and the polling doesn't necessarily matter
    - ☐ Kelsey wonders if there's a way to make it a yes/and. Yes, we believe in this no matter what folks say, AND also Carroll County is not even reflecting the majority of their own constituents
    - ☐ Tamar also emphasizes that the group is a minority group, a small group of people wanting to make decisions for the community
  - Tracy and Nay like saying "a small group with extremist views" to emphasize both points above
- Josh has been working on making our website a bit more locked down, which requires you to log in to access certain materials
- Tiffany will make edits based on the discussion and run it by Andrea before getting the final votes needed

# **Legislative Update**

#### □ State

- Libraries will have a number of bills in the 2024 state legislative session. The Maryland Association of Public Library Administrators Inter-Governmental Relations Task Force (MAPLA IGRTF) is taking the lead on drafting the bills.
- SLRC Funding: Will ask for an increase to the five-year funding cycle for the State Library Resource Center (SLRC).
- Freedom to Read: Bill is being developed by diverse committee of public, academic and school library leaders and representatives from MLA, Maryland Association of School Librarians (MASL), EveryLibrary, Penn America and Penguin Random House. The proposed legislation addresses public, school, and academic libraries and includes protections for collections, staff and library funding. Governor Moore requested and supports this bill.
- o Collective Bargaining: Will likely introduce a bill again.
- Maryland Library Legislative Day is Tuesday, February 13, 2024.

- Appropriations: Federal budget year ends 9/30/2023. Appropriations bills have not yet passed. If the appropriations bills are not passed, one of several things could happen: 1) an omnibus bill is passed (combines two or more appropriations bill into one bill that can be passed with one vote in each house of Congress); 2) a government shutdown (some say a few weeks or a couple of months); or 3) a continuing resolution is passed (keeps government funded at FY23 levels for a set period of time; this is most likely).
- Right to Read Act (HR2889 / S1307): This bill puts school librarians in school libraries; provides liability protections to teachers and school librarians; provides \$500M for Comprehensive Literacy State Development Grants; and provides \$100M for Innovative Approaches to Literacy (IAL). In MD, only Representative Trone is co-sponsoring the bill. There has been no further movement.
