Treasurer's Report

Balance Sheet

- Total bank accounts ended with \$257,239.76
- Total other current assets ended with \$139,101.19, nearly the same as last year
- Total current assets ended at \$400,035.95
- Accounts payable were minimal at \$.33
- Retained earnings of \$252,120.31 were just under 12% higher than last year
- Liabilities and equity balance at \$400,035.95, which is 48.75% higher than 2021
 Profit & Loss
- Annual conference income as of April 30th was \$204,685.36, an increase of 26.21% over April of 2021
- LLT committee remains at \$300, down almost 92% of April 2021

- Jobline income was at \$3,025, an increase of 74.35%
- Memberships of all kinds arrived at \$60,382, down by 6.82% of April 2021
- Group program income stands at \$5,543.75, 15.22% lower than April 2021
- Total income was therefore \$277,270.89, an increase of 6.07% over April 2021
- Conference expenses so far are at \$17,282.11, down 65.77% of April 2021
- Bank and credit card fees come to \$9,307.02
- Office expenses ended April with \$10,473.83, just under 10% higher from last year
- Personnel expenses finished last month at \$75,768.79, 25.21% below last year
- Program expenses finished at \$950, which is down 43.49% from the same time last year
- Total expenses were \$131,122.20 down 40.15% from April 2021
- Net income was \$147,916.35, an increase of 238.2% over April of 2021
 Budget vs. Actuals
- Income at the end of April was at \$204,685.36, which is 102.34% of the budget
- Fundraising income is at \$1,717, 8.59% of the target budget
- Jobline income is \$3,025 against a budget target of \$3,500, or 86.43% of the budget
- Membership dues of \$60,382 is just over 70% for the year
- Program income comes in at \$5,543.75, which is just 22.18% of the budget
- Total income of \$277,270.89 is just over 75% of the budget
- Conference income ended April at \$17,282.11, just over 15% of the budgeted amount
- Bank and credit card fees ended April at \$9,307.02, 117.81% of the budget
- Scholarships were budgeted at \$4,000 and, by the end of April, we'd dispersed \$950, 23.75% of the budget
- By the end of April, we used \$10,473.83 for Office Expenses, just over 63% of the budget
- Program expenses are at \$950, or 19% of the budgeted amount for expenses
- Total expenses so far are at \$131,122.20, or 35.61% of the budgeted expense
- Net income is at \$147,916.35, against a projected loss of \$2,000

- Lisa Swain (PSD) PSD had 10 sponsored programs at the conference, along with the unconference which was a huge success. Looking forward to next year
- Jill Hutchison (CSD) Continuing to meet monthly on the 2nd Monday of each month on Blackboard. Next year, there will be one meeting/quarter that will be hybrid so attendees can enjoy touring other children's spaces. The Spring Black Eyed Susan Tapestry, focused on picture books, was a huge success. The Fall Black Eyed Susan Tapestry will be focused on graphic novels. <u>Maryland Blue Crab</u> <u>awards</u> were announced earlier this year. Sharon Young will be the chair for 2023. They are currently recruiting for that team – work will begin June/July. The webinar series to replace the Kids Are Customers conference will likely happen in the summer.
